Subject: Notification regarding Submission of Online application instead of submission of offline application for Surface Water demand.

With regards to Surface Water demand, an online system has been developed with the following features without the requirement of a physical visit to the Department: -

- Submission of application.
- ii) Payment of application fee.
- iii) Track the status of the application.
- iv) Third-party verification.
- 2. In the context of the above the online system as mandated to be implemented for the development of requisite mandatory provision for receiving only online applications from the database has already been notified and uploaded in the departmental portal the URL: https://pwdwr.tripura.gov.in/ with hyperlinking to https://swaagat.tripura.gov.in maintained by the Director of Industries and Commerce, Government of Tripura. Applicants need not to visit the office physically for submitting applications.
- 3. For Surface Water Extraction permission in case of Domestic/Commercial/Industrial a one-time processing fee of Rs. 1000.00 (Rupees One thousand) only is required to be paid after submission of application at the portal.
